Payment Method

i) Bank transfer (preferred method) to HSBC business account name Bradford on Avon Sailing Club, account number 00433004, sort code 40-09-44, payment **reference MUST include your Surname to know who paid**. If any of your details or your membership type has paid, **please send a completed copy of the membership form to the Secretary** by email (boasailingclub@gmail.com).

ii) Cheque (non-preferred method) made payable to Bradford on Avon Sailing Club. Please send your cheque together with a completed copy of the membership form to the Treasurer (obtain address via email to Secretary).

Confidential application may be made to the Treasurer for the payment of the annual subscription by instalment, if adverse financial circumstances exist.

Payment Requirements & Conditions

Membership and any storage fees should be paid before March each year to enable the sailing rota to be finalised & for financial management. No sailing is permitted at BoASC until the relevant membership fee has been paid.

Payment of a membership fee means that you are confirming that **you have valid insurance for third party risk for any of your boat(s)** to be sailed at BoASC.

Payment of a storage fee means that **you agree to the terms and conditions of boat storage** which are shown below and displayed on the notice board.

Terms and Conditions of Boat Storage v1

Application and payment for boat storage should be made to the treasurer annually at the time of membership renewal. Applications will also be considered throughout the year when space is available.

Spaces will be allocated firstly to members who held a space in the previous year and then to members on a first come first served basis. The committee reserves the right to reallocate spaces to make the best use of the available space.

Boats and/ or trailers stored at the club remain the responsibility of the owner and are left entirely at the owner's risk. The club will bear no liability whatsoever for damages to or resulting from boats and/ or trailers stored in the boat park and not owned by the club.

Boats, trailers and parts thereof left at the club should be labelled with dinghy class & sail number.

Abandoned Boats and/or Trailers:

If, at any time, any fees payable to the club by any member or former member (whether by way of arrears of subscription or facilities fees, dinghy park fees or otherwise) shall be one month or more in arrears and a boat and/or trailer the property of a member or former member remains upon the club premises then the member or former member shall remove the boat and/or trailer from the club immediately. If the member or former member fails to remove the boat and/or trailer then the Committee may:-

(a) Move the boat and/or trailer to any part of the club premises without being liable for any loss or damage to the vessel however caused.

(b) Give three months' notice in writing by post to the member or former member at his last known address as shown in the Club Register and thereafter sell the boat and/or trailer and deduct any monies due to the club from the net proceeds of sale before accounting for the balance (if any) to the member or former member.

(c) Alternatively, if the boat and/or trailer is unsaleable, after giving notice in writing as aforesaid, dispose of the boat and/or trailer in any manner the Committee may think fit and deem the cost of doing and any arrears as aforesaid to be a debt owing to the club by the member or former member.

(d) the club reserves the right to charge storage for the boat and/or trailer until such time as the owner collects the boat and/or trailer or until notice has been served under clause (b) above.

In the event that a Boat and/or Trailer is considered by the committee to be abandoned the committee will take reasonable steps to trace a member or former member and that when and if the boat and/or trailer is sold the proceeds of sale (unless any indebtedness by the member or former member to the club) shall be placed upon bank deposit account and retained against the eventuality of a claim by the owner (whether he be the said member or former member or otherwise) for a period of six years.
